- **Zoning Ordinance Amendment:** A preliminary draft was delivered to each Council member for review. To be discussed at the next meeting.

- Hale Conditional Use Application: Public Hearing scheduled for November 4, 2020 @ 5:00 pm prior to Council meeting.
- **Blight:** 138 Elm Street proposals from Nicholson Excavating, LLC for \$16,560.00; Passauer Excavation, Inc for \$14,950.00; and Keith White Excavating for \$8,700.00, reviewed and discussed. Denny O'Toole moved to award the project to Keith White Excavating contingent on County CDBG grant funding, 2nd by Jamie Say, motion carried. Denny asked if there was a fee to disconnect the electric service. Cindy will check.

- Garbage Pickup Complaint: Cindy checked with Advanced Disposal to see if they would pick-up on German Hill Road. Council directed Cindy to notify German Hill residents to see if they wanted to place their garbage out on German Hill Rd for pickup or if they want to continue bringing it to the Borough office dumpster.
- **Empowers Grant:** Cindy is waiting on the report from LTAP for the down town crosswalk signs before completing the grant application.
- Tionesta Creek Bridge Sidewalk: Cindy spoke with Steve Schettler with PennDOT and he wanted to know if the Borough wanted a sidewalk on the bridge. PennDOT is requiring the Borough maintain the sidewalk during the winter months for snow removal. The Borough doesn't have a wing plow or a snow blower. After discussion, Council decided against the sidewalk. It is expected that the new bridge will have a wide shoulder only.

New Business:

- **Library CD:** The \$31,000 CD is scheduled to mature on 10/30/2020. Tom Mohney moved to reinvest the principal and \$500 of the interest (if possible) at the best rate and term available for up to 1 year, 2nd by Doug Chappel, motion carried.
- **2020 Recycling Grant Award:** The Borough is expecting a grant payment of \$280 for its 2019 recycling efforts.

• **Elderly Housing Board:** Louise Fedora resigned from the Board due to health issues. Council will address appointing her replacement at the next meeting.

- Forest County Board of Assessment Appeals Decision: The appeal board decided in favor of the Tionesta Plaza application and the Forest Scientific application. The new assessed value for the Tionesta Plaza real estate will be \$44,960 for 2021 and \$71,940 for the Forest Scientific real estate for 2021.
