# TIONESTA BOROUGH COUNCIL MEETING MINUTES May 19, 2020

Public Works: Kent reported that the Miller/Bickel water line repairs have been completed. The repairs to the jungle gym in the beach park have been completed. The streets were cleaned earlier this month. There was a substantial leak at the Methodist Church Parsonage that will be repaired by the church. This should take care of the water that has been collecting behind the homes in that area.

#### Old Business:

- GIS Mapping: Nothing new to report.
- Council Run USDA Loan and Grant: Tom Mohney moved to authorize the execution of the USDA loan and grant documents as of May 22, 2020, 2<sup>nd</sup> by Bernadette Holzer, motion carried.
- Elm Street Water Line Project Phase 3 (Bridge to Highland k/n/a Sherman St): Grant award notice from the PA DCED for \$192,321 for

funding through the Appalachian Regional Commission dated May 13, 2020 reviewed.

- Walnut Street Storm Water Line Replacement: Nothing new to report.
- Zoning Ordinance Amendment: Nothing new to report.

### New Business:

- Flooding around the 209, 211 and 213 Elm Street area: Kent reported earlier that a leak at the Methodist Church Parsonage was discovered and he believes that should address the standing water behind the houses in that area.
- 2020 Dirt and Gravel Grant Application: Kent reported that he has been working with the County on a grant application to replace 3 pipes that run under S. Elm Street and Outflow Road as well as two headwalls. The project cost is estimated at \$18,575.20 and the Borough must contribute. Kent and Cindy requested the Borough commit \$475.20 to the project. Denny O'Toole moved, upon the award of a grant to the Borough for the S. Elm Street project, to authorize payment or disbursement of \$475.20 from the Capital account and directed Cindy to reduce the Sidewalk budget to \$4,524.80 and add a line item for this project to the budget for \$475.20, 2<sup>nd</sup> by Jamie Say, motion carried.
- Vine Street Storm Sewer Catch Basin Repair: Kent provided pictures of the problem. He reported he will begin replacing the pipe in the Borough's right of way soon. The junction box and the pipe upstream of the junction box are out of the Borough's right of way and are the responsibility of the property owner.
- Vandalism at Borough Ballfield: A shed located at the ballfield behind the hardware store was vandalized and broken into on or about 4/21/2020. The shed is not Borough property but owned by TS&R and any insurance claims must be under the TS&R policy.

## Non-Agenda Items:

- Catch Basin corner of Elm and Davis Streets: Tom Mohney reported on his observation during a recent rain storm. The grate is higher than the road causing the water to run directly into the road, bypassing the catch basin entirely. Cindy will write a letter to the County.
- Future Council Meetings: Council meetings will take place in person effective June 2. No more zoom meetings at this time.

- Mayor: Judy thanked Kent and the public works employees for the repairs made on the jungle gym at the beach park. She remarked the Borough has not closed the parks during the COVID-19 pandemic. Bernadette Holzer mentioned that she may have a funding source for the repairs. Kent or Cindy will get an estimate to repair or replace the damaged fencing and get it to Bernadette.
